General Terms & Conditions:-

1. The bidder must submit the PAN number and must have GSTIN number along with the tender document.
2. Only the bidder himself/herself or one authorized representative will be allowed to participate in the tender process. The authorization letter from the bidder should be produced by the representative participating in the tender process.

3. The history sheets of both the vehicles for auction are given in **Annexure-4**.
4. The bid must be accompanied by **Earnest Money Deposit (EMD)/Bid Security of Rs.4,000/- (Rupees Four thousands only)** in form of an accounts payee Demand Drafts/Pay Orders of any of the scheduled Commercial or Nationalised Bank drawn in favour of **“DDO, National Informatics Centre”** payable at **“Bhubaneswar”**, without which the bid will be summarily rejected. No Cheque/Money-Order/cash/Bank Guaranty shall be accepted.
5. The vehicles shall be sold to the highest acceptable responsive bidder.
6. The Earnest Money Deposit (EMD)/Bid Security of the successful bidder shall not be adjusted **against final payment of sale value**. It will be returned within 30 days on production of documentary proof of having deposited the sold amount in full to Government Account through **“Bharat Kosh”**.
7. The EMD/Bid Security of the unsuccessful bidders shall be returned within 30 days of the auction date without any interest.
8. No vehicles, once sold to the successful bidder, shall be taken back by NIC, on any condition whatsoever and it is the responsibility of bidder to carry the vehicles safely to his/her site.
9. **The highest responsive bidder will be required to deposit full payment of sale value of the vehicles to Government of India account electronically through “Bharat Kosh” (NTRP) using the URL <https://bharatkosh.gov.in> and produce the documentary proof (Transaction Receipt) in token of having deposited the full amount of sale value to Govt. account through “Bharat Kosh” within 5 (Five) days after receipt of confirmation from NIC, failing which the offer will be cancelled and EMD/Bid Security shall stand forfeited.**
10. The highest bidder/successful bidder shall be required to lift the vehicles from the sites to his/her premises within 3(three) days at the cost of bidder against payment of full amount of **sale value**. On failure to do so, NIC Odisha State Centre will have the right to forfeit the entire amount of the bidder deposited to Government account through **“Bharat Kosh”**.
11. The bid must be submitted on or before the due date, otherwise it is liable to be rejected. The bid received after due date due to any reason whatsoever including postal delay shall not be considered.
12. **The Financial bid should be quoted both in figures and words**. Any overwriting or erasing in the figure shall not be considered for acceptance of the rates offered by the bidder; **GST as applicable** shall be borne by the bidder.
13. NIC reserves the right to accept or reject any/all bids without assigning any reason whatsoever. Decision of NIC Odisha State Centre will be final and binding on the bidder.
14. Incomplete and unsigned bids are liable to be rejected.
15. The EMD deposited shall not attract any interest.
16. The minimum bid value should not be less than **Rs.40,000/- (Rupees Forty Thousand)** and not be less than the Reserve Price, failing which Financial bid will be rejected.

17. During Financial evaluation, the highest acceptable responsive bidder shall be chosen as successful bidder based on the figures quoted in **Annexure-‘B’: Financial Bid**.
18. Financial Bids of only those bidders will be opened who have qualified in the Technical Bid.
